Direct management of the MOAC, including grant making via the Boston Cultural Council, commissioning and approving public art via the Boston Art Commission, the operation of the Strand Theater, and oversight of the Mayor's Mural Crew and the Poet Laureate Program. Major accomplishments: leadership of the *Boston Creates Cultural Plan* (2016) community process, plan publication and two years of initial implementation. Launch of new programs: Percent for Art for Boston capital projects, BostonAIR (Artists in Residence in Government) Opportunity Fund Grants, Artist Fellowship Grants, Emerging Artist Award, creation of Artist Resource Manager role. Growth in funds granted out by over 485%. Growth in municipal arts spending from \$1.5 million to over \$4 million from FY 2015 to FY 2018. Incorporation of BC goals in community plans, development projects and the Imagine Boston 2030 Comprehensive Plan and the inaugural Arts Innovation District in Uphams' Corner.

City of Chicago Department of Cultural Affairs and Special Events (2000 – 2014)

*Director of Cultural Planning*— Headed the creation of the *Chicago Cultural Plan* in 2012 as project manager and editor. Duties ranged from designing scope and goals to securing funding, managing grants and contracts, maintaining budgets, hiring consultants, and leading internal and external teams. Public engagement process inspired the creation of the first Arts Education Plan for the Chicago Public Schools. Leadership of plan implementation for two years resulting in 50% of plan initiatives bring addressed. Implementation highlights: Creative Schools Fund seeded, Night Out In the Parks launched; Cultural Tourism Strategy created and pilots programs funded; Great Chicago Fire Festival planning; and the publication of an Arts and Culture Toolkit by the Chicago Metropolitan Agency for Planning (CMAP) creation and launch of new grant program for major cultural institutions: IncentOvate Culture.

Cultural facility development expertise resulted in dozens of realized projects. Role ranged from foundational research and analysis, securing municipal financial assistance from GO Bonds, TIF funds, and the granting of surplus public buildings, to a revamp of the zoning code for cultural uses, a new performing arts venue license, and to technical assistance to the arts community focused on strategic growth issues and overcoming regulatory hurdles in the development process. Cultural district development support beginning with the Downtown Theater District Study and Market Potential, the renovation and disposition of the Chicago Theater, creation of the Prairie Avenue interpretive streetscape, feasibility planning for a creative industries district, and support for the development of the Uptown Entertainment District.
